	Collections Admin	14950, 16882	Added new Re-Age if Denied checkbox to the Collections Admin / External Collections / External Collection Rules section. This allows denied lines to be re-aged and to quality again for external collections if payments are not made.
		16729, 16881	Added new Apply rules at the account level checkbox to the Collections Admin / External Collections / Payment Exclusions section. If selected, the system looks for a guarantor payment at the account level instead of the service line.
			Added new Move all procedures by DOS into external collections checkbox to the Collections Admin / External Collections / External Collection Rules section. If selected, when a service line for a DOS becomes eligible for external collections, then all other service lines in guarantor responsibility for the same DOS & Case ID are also be pulled into the external pending queue for approval.
