	General	7211	Fixed the issue causing computers (MAC) to lock up during charge entry and entering patient demographics.
	Payment Batches	7271	Fixed the issue (system processing time) causing an error message when attempting to post a payment batch.
		7469	Fixed the issue on the <b>Payment Distribution</b> page > <b>Add</b> > <b>Payment Transfer to Misc Income</b> window so if there is a check amount remaining, the amount populates in the <b>Check Amount Remaining</b> area.
	Preferences	5753	Fixed the issue causing an error when selecting <i>NUCC 1500</i> on the <b>Preferences</b> page > <b>Paper Claims</b> tab > <b>Printing Offsets</b> section > <b>Claim Form</b> field.
	Printing	7317	Fixed the issue causing an error when trying to print letters and demand statements from the <b>Practice</b> page > <b>Guarantor Collection</b> tab.

		7492	Fixed the issue causing no records to display when <b>Payer</b> selection is set to <i>All</i> when conducting a search on the <b>Claims</b> page > <b>Paper Claims</b> tab.
		7407	Fixed the issue causing no records to display when <b>Practice</b> selection is set to <i>All Practices</i> when conducting a search on the <b>Misc Income</b> page.
	Create Person	7353	Fixed the issue causing the <b>Cancel</b> or close <b>X</b> buttons to not work if a new patient's name and DOB is entered in the <b>Patient</b> window. It is now possible to back out of the <b>Patient</b> window during creation if the record has not yet been saved.
